Can You Name This Aircraft? It's a CL-84

In the March 30th issue of Voxair, we published a photo of a mystery aircraft. Among the many replies received was Bill Brown's of the Restoration Department of the Western Aviation Museum. He has provided us with the following story.

Editor's comment

The CL-84-1 V/STOL aircraft was developed from the prototype programme specifically for evaluation by the Canadian Armed Forces in a large number of operational roles as well as V/STOL training.

The aircraft is designed to be flown by one pilot. Dual controls and side-by-side seating are provided for a check pilot or observer on the right side. Every effort has been made to minimize the pilot's work load. The aircraft is flown in all flight modes by conventional stick, rudder pedals, and single power lever. There is no collective pitch lever.

Aft of the crew compartment is a rear loading passenger/cargo compartment which has complete seating provisions for 12 passengers.

The wing on the CL-84 is hinged at the 45% chord station and is rotated by means of a hydraulic ballscrew actuator. It can be tilted to a maximum of 100°, allowing hover in a 30-knot tailwind. The low aspect-ratio

constant-chord wing is almost entirely immersed in the slipstream and employs Canadair-developed leading and trailing edge flaps along the entire span. The flaps and variable-incidence horizontal stabilizer are automatically programmed with wing tilt to reduce pilot attention and effort during transition.

Power is supplied by two Lycoming T-53 turboshaft engines which are currently in widespread use in both military and civil helicopters. Two interconnected 14-foot four-bladed lightweight glass-fibre propellers provide vertical lift and forward propulsion. In the event of engine failure, or if one engine is shut

down for economical cruise, the dead engine is automatically de-clutched from the system and both propellers receive equal power from the remaining engine.

The landing gear is retractable and has dual wheels on main and nose wheel assemblies. Its design, combined with low footprint

pressure, permits usage on unprepared terrain. Each main wheel assembly is equipped with hydraulic disk-type brakes operated from the rudder pedals. Effective ground steering is provided by rudder pedal authority over differential propeller pitch and normal use of main wheel brakes.

On 19 Mar 88, four visiting F-18's stopped into CFB Winnipeg on their way down to an exercise in Florida, USA. After being refueled, one of the aircraft had an unsafe indication for the hydraulic system on start up. The indicated pressure in the system was low and the equipment required to get it back up was not held in Winnipeg.

Cpl Sylvie Grant (#1 Crew, ASO/TTT), an airframe technician, was summoned from 10 Hangar as she had previously worked on F-18's in Cold Lake, Alberta when they first came into service. Despite the lack of equipment and not having worked on the system for a number of years, Sylvie managed to get the pressure in the system back, thus allowing the aircraft to continue towards its mission with minimum delay.

For her professionalism in dealing with the problem, and commitment in completing the job right to the point of seeing off the aircraft, Cpl Grant is BAMEO's Airwoman of the Month for May/88.

Sylvie is married to another "rigger", MCpl Colin Grant of #3 Crew, ASO/TTT and they have two kids. She will enjoy the use of Major Tudor's executive parking space for the month as part of her gift package.

...and the Dak goes on

The venerable Dakota, a familiar sight at CFB Winnipeg, is nearing the end of what has been an extremely long tenure with the CF. Recent developments have indicated that the upcoming Depot Level Inspections will not have a contractor to perform them, and the DC-3 will most likely see its flying cease entirely sometime in 1989.

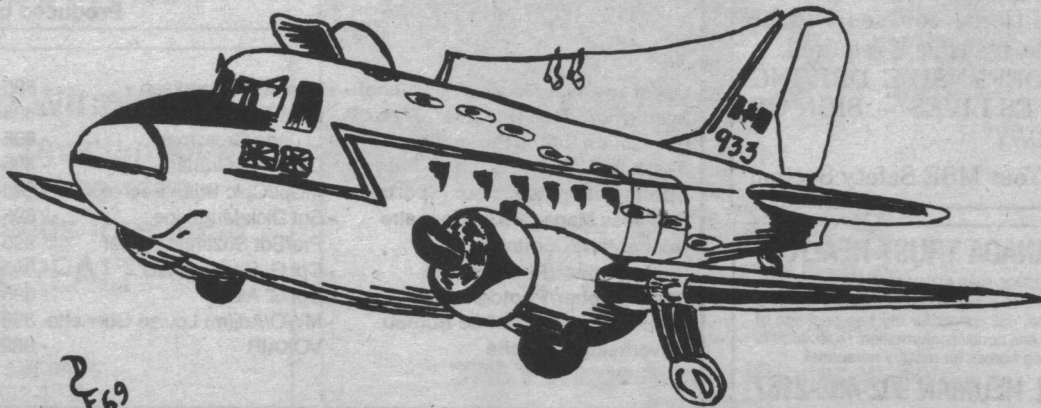
In an effort to provide a bit of history of some of the remaining fleet, this will be the beginning of a short series of articles. Specifically then, the background of Dakota 12933 as it appeared in Beartrax Oct '86 (researched and

submitted by Sgt K. Boswell and Cpl R. Schwindt of 402 Sqn).

Dakota 12933 was manufactured by Douglas Aircraft in Oklahoma City in 1944, with Douglas Constructors No. (C/N) 13383, as C-47-ADK, and delivered to the U.S. Army Air Force on 22 May 44 as Serial No. 42-93468. Four days later (on 26 May 44), it was transferred to the Royal Air Force in Montreal and assigned Serial No. KG623, as Dakota MX III. On 31 May 44, it was transferred to 437 Squadron in Croydon, Surrey. Ownership was transferred to the Canadian Government on 16 Jun 46, and to the R.C.A.F. on 9 Sep 46. In 1952,

it was flown by 1 ANS in Winnipeg and was assigned I.C.A.O. Code VC-GSG. It was reassigned Serial No. 12933 in 1970, when the CF decided that all Dakotas would become "CC-129" instead of MK IV ST, MK III MN, MK III N, etc. Until 1979, Dakota 12933 was flown by 429 Squadron as a radar trainer. Since 1979, it has been flown by both 429 and 402 Squadron as part of the transport configuration.

Dakota 12933 at present is approximately 150 flying hours from her Depot Level Inspection, and is forecast to see her last CF flight sometime this year.

In August 1969, a group of Scuba Divers from the North Bay Aqua Jets recovered an old flying boat from the bottom of a lake in Northern Ontario. The aircraft was an HS-2L, number 3 in the civil aviation registry in Canada (G-CAAC), the first bush aircraft in Canada, called "LA VIGILANCE".

Divorce — Canadian Style

In 1985, Canada's Divorce Laws were amended, most noticeably in relation to the grounds which must be satisfied before one qualifies for a divorce. At the present time, the only ground for divorce is marriage breakdown as it is specifically defined in the Divorce Act.

Such a condition can only be satisfied in one of three ways. One way is for the spouses to have lived separate and apart from each other for at least a one year period immediately prior to the finalization of the divorce proceedings and were living separate and apart at the commencement of such proceedings. If a one year separation will be the reason for the marriage breakdown, you do not have to wait until you have been separated for one year before starting divorce proceedings. You may apply for a divorce as soon as you separate from your spouse, but the divorce will not be granted until you have been separated for at least one year. A second way is if the spouse against whom the divorce proceeding is brought has committed adultery. The third way to prove marriage breakdown is to show that the spouse against whom the divorce proceeding is brought has treated the other spouse with physical or mental cruelty making it impossible for the spouses to continue to live together.

Practically speaking in the usual situation, one of the spouses must cause a Petition to be filed at the Court of Queen's Bench which Petition outlines various facts which pertain to the marriage and which claims the relief being sought including, for example, an order of custody, an order

of access, an order of spousal support, or an order of child support. Such Petition must be served upon the other spouse who is allowed the period of 16 days from the date of such service to file an Answer to the Petition. By the filing of such Answer, the spouse responds to the statements of fact and the claims for relief being made by the Petitioner, and such spouse can also make claims for relief similar to that being made by the Petitioner including a claim for a divorce. If the Respondent fails to file an Answer within the required period, the Petitioner can proceed with the finalization of the divorce either by an uncontested hearing during which the Petitioner must give evidence or informally by the filing of documents at the Court of Queen's Bench including an affidavit of the Petitioner. Either method of finalizing the Petition may result in a judgment being rendered granting the divorce.

If the Respondent spouse files an Answer or otherwise responds to the Petition, then the various relief claims can be resolved by a negotiated settlement or by a final determination of the Court at a trial of the matter. The proceedings involved in such case should be discussed with your legal counsel.

It is important to note that nor-

mally a divorce takes effect on the 31st day after the day on which the judgment granting the divorce is rendered. However, where special circumstances exist and where the spouses agree that no appeal will be taken, the court may order that the divorce is to take effect at an earlier time. A Certificate of Divorce may be obtained by either spouse at that time.

As indicated, at the time of the granting of the divorce, the court may also make an order requiring either spouse to pay support for the other spouse, for the children of the marriage, or for both and in making such an order shall take into consideration the financial circumstances of both spouses and the children, and also the length of time that the spouses cohabited, the functions performed by the spouses during cohabitation, and any order, agreement or arrangement relating to such support. The Divorce Act specifically indicates that the court shall not take into consideration any misconduct of a spouse in relation to the marriage.

An order made for the support of a spouse should also recognize any economic advantages and disadvantages to the spouses arising from the marriage or its breakdown, apportionment between

the spouses any financial consequences arising from the care of any child of the marriage, relieve any economic hardship of the spouses arising from the breakdown of the marriage and promote the economic self-sufficiency of each spouse. An order providing for the support of a child should recognize that the spouses have a joint financial obligation to maintain each child and should apportion the obligation between the spouses according to their relative abilities to contribute financially.

In dealing with the issues of custody and access or visitation rights to children, the only factor that the court will take into consideration is the best interests of the child as determined by all the relevant surrounding circumstances. The court specifically cannot take into consideration the past conduct of any person unless such conduct is relevant to the ability of that person to act as a parent. In addition, the court must also be guided by the principal that a child of the marriage shall have as much contact with each spouse as is consistent with the best interests of such child.

Custody and access orders pursuant to the Divorce Act relate to a child of both spouses, and also a child of either spouse from

a previous relationship, as long as the child is under the age of sixteen years or dependent upon the custodial parent for one of a variety of reasons. Similarly, the Court has jurisdiction to order that one spouse pay maintenance for any child of one of the parents from a previous relationship for such period of time.

Finally, it is important to note that either party may apply to the Court prior to the granting of the divorce for an interim order respecting either custody, access, or maintenance which order would be in effect from the date of the order until the finalization of the proceedings by a divorce.

The new Divorce Act enacted in 1985 has updated the previous legislation in many respects. Most significantly to the layman it has broadened the grounds, or those circumstances in which spouses can obtain a divorce. Such appears to be happening with the liberalization of morality. As a result, sometime in the future it would appear possible that the legislation may be further amended in this regard.

King Solomon of the Old Testament Bible remembered the vital importance of Motherhood when he wrote: "Strength and dignity are her clothing, and she laughs at the time to come. She opens her mouth with wisdom, and the teaching of kindness is on her tongue... Her children rise up and call her blessed; her husband also, and he praises her. Many women have done excellently, but you surpass them all!" (Proverbs 31:25-29)

We may not be fortunate enough to have our Mother with us to share the feelings of Mothers' Day but they are yet there in the hearts and minds of families everywhere. The Chapel of St. Andrew (S.S.) celebrated the Special Day with the Asst Comd Chap (P), Padre A. Flath, officiating Communion and Divine Services. The Sunday School and Nursery has enjoyed a very

busy and productive year through the fine support of the Teachers and they are planning a Sunday School graduation and a Congregational Picnic on Sunday, 29 May. This should be a day off from the kitchen for Mom as the Picnic Lunch will be held on the Chapel lawn.

We can say many things about Mothers, good and bad I suppose; but looking back on it all, it is clear that the greatest single gift which Mothers render, is their LOVE. Not always the affectionate embracing kind of love was given but sometimes for our own good, wise Mothers could "dish out" the "tough love" by which we learned and grew. Erma Bombeck, a Mother and author, wrote the following letter which she hoped to show her children someday to better understand what motivates a mother. She would tell them:

"I loved you enough to bug you about where you were going, with whom, and what time you would get home.

I loved you enough to insist you buy a bike with your own money.

I loved you enough to keep silent and let you discover your hand-picked friend was a creep.

I loved you enough to make you return a Milky Way with a bite out of it to a drugstore and confess, "I stole this."

I loved you enough to stand over you for two hours while you

cleaned your bedroom, a job that would have taken me 15 minutes.

I loved you enough to let you see anger, disappointment, disgust and tears in my eyes.

I loved you enough to ignore what "every other mother" did.

I loved you enough to figure you would lie about the party being chaperoned, but forgive you for it — after discovering I was right.

I loved you enough to shove you off my lap, let go of your hand, be mute to your pleas, and insensitive to your demands — so that you had to stand alone.

I loved you enough to accept you for what you are, not what I wanted you to be.

But most of all, I loved you enough to say no when you hated me for it. That was the hardest part of all."
